Chairman Abild called the meeting to order at 3:00 p.m.

APPROVAL OF AGENDA

The Board reviewed the agenda for the meeting. There being no changes, Director Iverson moved to approve the agenda. Seconded by Director Chadima. Motion passed unanimously.

Chairman Abild asked if any Directors had a conflict of interest in regards to any agenda item. No conflicts were noted.

APPROVAL OF OCTOBER MEETING MINUTES

Chairman Abild asked for any additions or corrections pertaining to the Board of Directors meeting minutes from October 18, 2023.

TM RURAL WATER DISTRICT - PROJECT ASSISTANCE REQUEST

General Manager Jay Jorgensen attended the meeting to discuss recent activities of the TM Rural Water District. They have identified a critical need to drill multiple test wells and test their pumping capabilities in order to select the most promising site for a new well. They believe this new well will enhance water supply reliability and contribute to the long term sustainability of TM's water infrastructure. The cost of the testing could be over \$100,000.00 and they are seeking cost share assistance from the VBWDD.

Following discussion, Director Iverson moved to grant \$20,000.00 to the TM Rural Water District for test well drilling. Seconded by Director Dykstra. Motion passed unanimously.

MCCOOK COUNTY CONSERVATION DISTRICT

1. <u>Resolution #23-10</u> - This resolution authorizes a grant of up to \$5,000.00 to the McCook County Conservation District to be used for tree planting cost share. The resolution also authorizes the VBWDD to enter into Grant Agreement #08-23 with the McCook County Conservation District. Following review, Director Dykstra moved to approve and sign Resolution #23-10. Seconded by Director Chadima. Motion passed unanimously.

2. <u>Grant Agreement #08-23</u> - This grant agreement has been returned from the McCook County Conservation District with the

proper signatures. The grant is for the amount of up to \$5,000.00 and is to be used for tree planting cost share. Following review, Director Chadima moved to approve and sign Grant Agreement #08-23. Seconded by Director Dykstra. Motion passed unanimously.

2024 LEGISLATIVE ITEMS

East Dakota Water Development District Manager Jay Gilbertson joined the meeting via phone to give an update on upcoming legislative items of interest to water development districts.

PROJECT UPDATES

The Board discussed ongoing projects of interest to the District that included the City of Centerville, Clay Rural Water System, Town of Chancellor and McCook County Wildlife Club.
